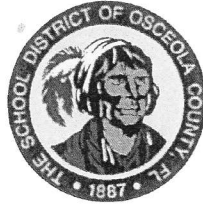

**FIRST AMENDMENT TO  
INTERLOCAL AGREEMENT BETWEEN THE SCHOOL BOARD OF OSCEOLA COUNTY  
AND THE SCHOOL BOARD OF POLK COUNTY  
(New Dimensions High School)**

**THIS FIRST AMENDMENT TO AGREEMENT** ("First Amendment") is by and between **The School Board of Osceola County, Florida**, (hereinafter "Osceola School Board"), whose address is 817 Bill Beck Boulevard, Kissimmee, Florida 34744, and **The School Board of Polk County**, (hereinafter "Polk School Board"), whose address is Post Office Box 391, Bartow, Florida 33831.

**WHEREAS**, the parties entered into that certain Interlocal Agreement for New Dimensions High School with an effective date of September 4, 2009; and

**WHEREAS**, the parties desire to amend that Agreement with this document.

**NOW, THEREFORE**, the parties hereto amend the Agreement as follows:

1. The Recitals in the WHEREAS clauses are incorporated by reference and made a part of this Agreement.
2. The parties agree that the term of the Agreement shall be extended for the 2010-2011 school year, which school year commences August 2010.
3. Except as herein expressly modified, the First Amendment to Interlocal Agreement between the School Board of Osceola County and the School Board of Polk County (New Dimensions High School) shall otherwise remain in full force and effect, subject to all terms and conditions therein.
4. This First Amendment shall be effective on the last date approved by a party.
