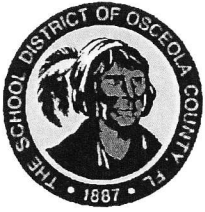

THIRD AMENDMENT TO INTERLOCAL AGREEMENT BETWEEN THE SCHOOL BOARD OF OSCEOLA COUNTY AND THE SCHOOL BOARD OF POLK COUNTY
(New Dimensions High School)

THIS THIRD AMENDMENT TO AGREEMENT ("Third Amendment") is entered into by and between **The School Board of Osceola County, Florida**, (hereinafter "Osceola School Board"), whose address is 817 Bill Beck Boulevard, Kissimmee, Florida 34744, and **The School Board of Polk County**, (hereinafter "Polk School Board"), whose address is Post Office Box 391, Bartow, Florida 33831.

WHEREAS, the parties entered into that certain Interlocal Agreement related to New Dimensions High School with an effective date of September 4, 2009; and

WHEREAS, said Interlocal Agreement was amended by the First Amendment to Interlocal Agreement dated November 16, 2010, and the Second Amendment to Interlocal Agreement dated August 23, 2011; and

WHEREAS, the parties desire to further amend the Agreement with this document.

NOW, THEREFORE, the parties hereto amend the Agreement as follows:

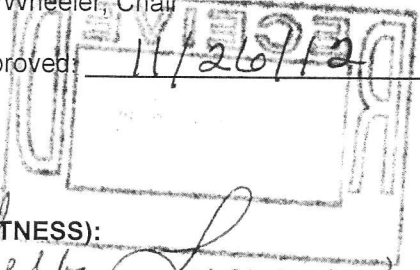
1. The Recitals in the WHEREAS clauses are incorporated herein by reference and made a part of this Agreement.
2. The parties agree that the term of the Agreement, as amended, shall be extended for the 2012-2013 school year, which shall commence in August 2012.
3. Except as herein expressly modified, the Interlocal Agreement related to New Dimensions High School between the School Board of Osceola County and the School Board of Polk County, as amended, shall otherwise remain in full force and effect, subject to all terms and conditions therein.
4. This Third Amendment shall be effective on the date last signed by both parties.
