Third Amendment to Agreement

THIS THIRD AMENDMENT TO AGREEMENT ("Third Amendment") is made and entered into by and between **THE SCHOOL BOARD OF OSCEOLA COUNTY, FL** (hereinafter referred to as the "BOARD"), a body corporate and political subdivision of the State of Florida, whose principal place of business is 817 Bill Beck Blvd., Kissimmee, FL 34744 and **NEW DIMENSIONS HIGH SCHOOL, INC.** (hereinafter referred to as "SCHOOL"), located at 4900 Old Pleasant Hill Rd., Kissimmee, FL 34759.

WHEREAS, BOARD and SCHOOL entered into that certain Original Food Service Agreement dated August 4, 2020, First Amendment dated June 15, 2021, and Second Amendment dated May 17, 2022, for participation in the National School Lunch Program, the National School Breakfast Program, and the After School Snack Program, and

WHEREAS, the parties desire to amend that Agreement with this document.

NOW, THEREFORE, the parties hereto amend the Agreement as follows:

1. The Recitals in the WHEREAS clauses are incorporated by reference and made a part of this Agreement.
2. The current Agreement is scheduled to terminate on June 30, 2023. The parties hereby agree to extend the term of the Agreement for an additional one (1) year commencing on July 1, 2023 and ending on June 30, 2024 ("renewal period").
3. Amendments to paragraphs 2.05, 2.07, and 2.14 will remain in effect.
4. Except as herein expressly modified, the Original Food Service Agreement dated August 4, 2020, First Amendment dated June 15, 2021, and Second Amendment dated May 17, 2022 for participation in the National School Lunch Program, the National School Breakfast Program, and the After School Snack Program shall otherwise remain in full force and effect, subject to all terms and conditions therein.





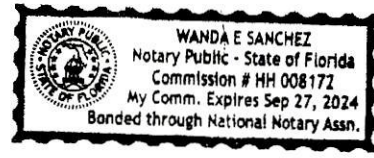
